The following points are required to be mentioned in Affidavit (Affidavit sworn before Executive Magistrate of the Claimant).

- Family detail with Name, Relation, DOB, Marital status, Present/Current status, Remarks (Eligible/ Not eligible).
- 3. If widow (Name, Marriage date, Expired date of husband along with death certificate Govt./Non Govt.
- 4. Widow detail whether taking pension from any other source with amount of pension.
- Unemployment (I am not employed in any Government, Semi Government, Government added Institution or any private sector)/Un married/ Widow / Divorcee daughter & dependency on parents.
- In case of divorcee daughter (Name, Marriage date, divorce date mention if alimoney or maintenance eligible/ granted as per court orders.
- 7. No. of Children disabled/ Handicapped or Mentally Retarded in the family.
- 8. Other declaration as per requirement of case.
- 9 Any specific condition as per case requirement
- 10. N O C from other family member stating reason.
- Declaration with regard "I do not have any other bank account any where other than which is submitted herewith".
- 12. Declaration stating "I had surrendered my family & Medical I card copy of same enclosed."
- 13. Declaration Prima facie proof of dependency on pensioner must.
- 14. "I had not given any false statement or documents to become eligible for family pension and in case in future, if I get married/on getting job, I will intimate this office immediately to stop my pension. Not obeying any Govt. rules, I shall subject to criminal/other legal proceedings as deem fit under I.P.C. 199,200."
