**TERMS AND CONDITIONS , ELIGIBILITY CRITERIA**

- 1) Employees must have passed the Medical Category :- Bee One
- 2) Employee should have three years continuous regular service as on the date i.e 03-04-24
- 3) Should be able to read and write in English and Hindi & Must possess a valid Heavy Motor vehicles Driving License and be able to Drive the same smoothly and have driving experience of one year in Mumbai and Navi Mumbai. Elementary knowledge of repairs of motor vehicle/motorcycle riding will be an additional qualification.

Application received only under reference to this notification will be considered. Service Particulars to be furnished as indicated in application specimen enclosed. All the regular employees of all departments including JRH, HQ office, EMU/MX & Parel workshops including BCT Division in the PB Rs. 5200-20200-1800(GP) (Level-1) possessing the prescribed Eligibility criteria shall be eligible to appear. However preference will be given to employees of the Mechanical Department.

**Mode of Selection:**

The incumbent for the above post will be selected through a process of Trade Test & review of working report and interview by the trade testing authority.

Every employee applying for the above post should submit filled in application form to their Controlling Officer/Unit in-charge and the application of eligible employees as per the eligibility criteria to be forward to this office. The staff who desires to apply for the above post should apply only ONLINE after the application is forwarded by the branch officer on our official website [http://203.153.40.19/bct\(ekarmik\)](http://203.153.40.19/bct(ekarmik)) on ekarmik bct application available in Google play store from 03-04-24 to 25-04-24.

It should be ensured that the applications are submitted to this office well within time and Applications submitted/forwarded after cut -off date i.e. 25-04-24 will not be entertained.

Once the applications are forwarded by the controlling Officer/Unit in-charge and subsequently if the employee gets selected, it will be binding for the concerned controlling Officer/Unit in – charge to relieve the employee to join the post of MLD Gr.III.

Along with the filled in application form, attested copies of the Educational Qualification, Technical Qualification, Heavy Motor vehicle driving licence and caste certificates should be attached with the application form. .

Incomplete application will be rejected.

On selection, the incumbent will be absorbed permanently in the Mechanical Department. The seniority will be assigned below all the existing MLD Gr.III working in Mechanical Department.

All Ch.OS/OS may ensure that the notification is dispatch to all concern units.
