Sub:- Notification inviting applications for promotion to the post of MVI in scale Rs 9300-34800+4200(GP) /Level 6 (General Selection) - Traffic Deptt-BCT Divn.

It is proposed to hold a selection to draw up a panel of suitable employees for promotion to the post of MVI in scale Rs 9300-34800+4200(GP) /Level 6 (General Selection). The selection will be conducted by holding a written test as well as scrutiny of records of service.

Eligibility Criteria :-

All Group 'C' employees working in Traffic Department regular service in the following eligible categories shown below as on the date of issue of notification are eligible to apply.

In case adequate of suitable employees from a particular is not available as per the above percentage, the short fall will be made good from the other categories shown above where suitable employees are available.

Once the employees appear for the selection of MVI in scale Rs 9300-34800+4200(GP) /Level 6 and secure placed on the panel, his refusal for promotion of MVI in scale Rs 9300-34800+4200(GP) /Level 6 will not be entertained and he will liable to dealt with under DAR.

The details of programme for conducting the selection is as under:

- 1. The willing & eligible employee should submit their application through E-Karmik on or before 02.12.24 till 18.00 hrs. All applications after the stipulated date or without enclosed documents uploaded will not be considered.**
- 2. No physical application will be entertain.**
- 3. Date & Venue of written examination will be advised later. All those who apply should start preparation & be ready to appear for the written test.**
- 4. Pre selection training of 21 days for SC employees only will be held at MDDTI/BL, programme of which will be advised later.**
- 5. The copy of the syllabus of MVI is enclosed.**
- 6. As per RBE No.196/2018 the question paper will be 100% objective type.**
- 7. As per RBE No. 194/2019 there will be negative marking @ 1/3 mark for a wrong answer.**
- 8. Duration of Examination will be 120 minutes.**
- 9. Once an employee applies he will ensure that he appears on the date of examination as THERE WOULD BE NO SUPPLEMENTARY TEST FOR THE SELECTION.**

In terms of HQ-CCG PS No. 073/2016 dated 14.07.2016 under ref. 06, the above selection has been initiated/ordered only after ascertaining quantifiable data of representation of SC&ST employees in the grade, as per the Roster for reservation against SC Roster Point No. 04 (3/12(C)) of Cycle I Temp Post Downgraded from GP 4600 to GP 4200) which is in compliance of orders of supreme court in M. Nagraj case.

In terms of Railway Board's letter No. 2018-E(SCT) 1/25/9 dated 28.12.2018 circulated vide GM€- CCG's letter No. E(SCT)220/0 Vol-X dated 31.12.2018(PS No. 194/2018), this selection is provisional and is subject to the final outcome of ongoing litigation/court cases pending on the subject.

As per RBE No. 147/2023 under reference 04, "The Hon'ble supreme court judgement in cases of R.K. Sabharwal and Jarnail Singh i.e. reserved category candidate can compete for non reserved post and in the event of their appointment to the said post their number cannot be taken into consideration for working out the percentage of reservation. Written test will be conducted as per guidelines received from Rly.Bd vide RBE No. 122/2023.

Those selected as MVI in Level-6 will be required to attend a course of training at Udaipur as well as to undergo practical training. The employee who will complete their training successfully will be eligible for promotion in accordance with the order of merit as determined by the selection board. The applicant should note that if refuse to work as MVI after the selection and training the entire period of training will be treated as leave due and excess amount drawn will be recovered and he will be not considered for promotion in future also

SS/CTNL/ Incharge should give wide publicity regarding above selection among the employees working under them & place it on the notice board .A copy of the above notification may be placed on the muster roll so that it is got noted by all employees. Acknowledge the receipt.

SYLLABUS FOR THE POST OF MVI SCALE RS 9300-34800+4200(GP)/Level-06

OPERATION

1. Station working: -SWR, T.W.O., Shunting, Responsibilities of station master
2. Signals: Standards, Type, Working & Defects, Interlocking principle.
3. Working of Trains: Passenger and goods trains electrified and non-electrified or accidents, protection of Trains, train parting.
4. Engineering Works: Grant of traffic and power blocks, working during blocks, L.C working and safety.
5. Safety: Ensuring various aspects of safety during station working and working of trains
6. Marshalling Yards and Terminals.
7. Section/ Track capacity and through put, calculation and measure to improve them.
8. Accidents: Types, classification and enquiries duties of SM during accidents, Relief and rescue measure and equipment's.
9. TMS, CRIS, FOIS operating statistics, inspections, Time Table., Divisional Control organization, 10 hours rules.

Commercial & Establishment:

1. Passenger amenities: Grievance, Complaints, Redressal.
2. Station Outstanding: Ist type and recovery.
3. Freight marketing: Indents, Rail road competition, efforts for new traffic, siding and goods sheds.
4. Station Earning: Freight Coaching, OCH
5. Frauds and Misappropriation.
6. DAR- Major/Minor penalties, leave rules, pass rules, Service Conduct rules, various allowance, and Confidential Reports.
7. Railway Act, Imprest, station Indents, Inventory, Prevention of Claims, Inspections, Tenders, it is type and process, Audit and accounts paras and objections, Ex gratia payment.
