**Ref:- Coverage under Railway Services (Pension) Rules, 1993, in place of National Pension System, of those Railway employees whose selection for appointment was finalized before 01.01.2004 but who joined Railway service on or after 01.01.2004.**

In terms of RBE No 28/2020 instructions contained in Department of Pension & Pensioners' Welfare (DOP&PW's) O.M. No. 57/04/2019-P&PW(B) dated 17th February, 2020 shall apply mutatis mutandis on the Railways. It provides that, in all cases where the results for recruitment were declared before 01.01.2004, against vacancies occurring on or before 31.12.2003, the candidates declared successful for recruitment shall be eligible for coverage under the Central Civil Services (Pension) Rules, 1972.

Such Government servants who were declared successful for recruitment in the results declared on or before 31.12.2003, against vacancies occurring before 01.01.2004 and are covered under the National Pension System on joining service on or after 01.01.2004, **have been given a one-time option to be covered under the CCS(Pension) Rules, 1972 for which they were required to apply on or before 31-05-2020.**

Consequent upon the above guidelines the following employees have submitted their applications to switch over from New pension Scheme to Old pension scheme before due dated i.e. on or before 31-05-2020.
